It was with great trepidation that I decided to try a new Evidence casebook, which utilized a problem approach so my students could get some hands-on experience in using the rules in a real-life setting. I knew that the switch would require me to do a lot more work than simply staying with the tried-and-ok-but-not-so-great, and it has. I'm happy to report that I'm thrilled I decided to put in the effort. The book has a very good balance between cases, notes, and problems, and it's theoretical yet straightforward. The cases Nicolas uses are current and illustrate the principles memorably. I expect that my students will do much better both on the final exam and in real life, the true test, as a result.
